This certificate is issued for the operations specifically described hereinafter. No person shall conduct any operation pursuant to the authority of this certificate except in accordance with the standard and special provisions contained in this certificate, and such other requirements of the Federal Aviation Regulations not specifically waived by this certificate.

OPERATIONS AUTHORIZED

Waivered airspace for a "Hot Air Balloon Event" with flight operations up to 10,000 feet MSL, within a 10 nautical miles radius of 39°31'54.3"N, 84°23'47.2"W (Middletown MWO airport center). Both MWO and other available open areas can be used for launch and recovery, as determined to be prudent for the conditions prior to launch. Note- 10nm is the limit of the waiver, but individual aircraft can begin or continue beyond this distance.

Times of the waiver are:

July 19: 18:00 - 20:59

July 20: 06:22 - 09:30, 18:00-20:59

July 21: 06:23 - 0930 local time

(Waiver is not valid outside of these times).
