Approval – Air Display 5th FAI Women's World Hot Air Ballooning Championship 2023

1 Duration

This instrument:

- (a) commences on 02 September 2023; and
- (b) is repealed at the end of 09 September 2023.

2 Definitions

In this instrument

application means a completed CASA Form - *Approval to conduct an Air Display and associated documents* submitted to CASA by the organiser.

air display means the air display mentioned in the application.

organiser is Northam Ballooning Events Inc, Aviation Reference Number (ARN) 1146002.

participant means the pilot in command of an aircraft being operated in the air display.

program of events means the program of air display activities provided with, or during the application process dated 18 July 2023.

Note: CASA has no jurisdiction over state aircraft participating in an air display. If the program of events includes state aircraft, this approval does not approve their participation.

3 Approval

- (1) For subregulation 91.180 (1) of CASR, I approve the organiser to conduct the air display.
- (2) For subregulation 91.180 (2) of CASR, I approve each participant listed in the program of events to undertake a flight in the air display.

Note: For the purposes of paragraphs 91.265 (4) (e) and 91.267 (3) (g) of CASR the

above approval extends to cover flight in accordance with the application.

4 Conditions

The approvals are subject to the following conditions:

1. A participant cannot carry a passenger(s) unless: (a) the participant is operating a balloon, and (b) the participant has procedures for the carriage of such persons, and (c) the air display organiser provides an approval to the participant in writing, to carry a passenger(s).
2. The organiser must ensure that the program of events is not changed except as follows:
 - (a) an event is cancelled; or
 - (b) the change is to the order or timing of individual events where:
 - i. the change does not affect the time of the end of the approved air display as mentioned in the application; and
 - ii. the organiser has briefed all participants affected by the change and given the participants an opportunity to identify any safety risks from the change; and
 - iii. the organiser records in writing the views of participants that the change will not have an adverse impact on safety; or
 - (c) with CASA's written approval.

Note: The limitations mean that CASA approval is required for new events, and the use of different pilots and aircraft to those mentioned in the application.

3. Within 14 days of the completion of the air display, the organiser must provide CASA with a completed *CASA Post Display Report* form.
